

Regular Council Meeting

Thursday, November 20, 2025

The Regular Town Council meeting was held by the Six Mile Town Council at Town Hall (106 South Main Street, Six Mile, S.C.) on November 20 2025, at 7:00 PM. Members in attendance were Mayor James Atkinson: Presiding; Council: Mark Beckman, Chis King, Beau Proffitt and Judy Shaw, and Attorney, Mary McCormac The agenda was emailed to the Pickens County Courier and the Journal on November 19, 2025.

Call to Order & Invocation & Pledge

Mayor Atkinson called the meeting to order, the invocation was given by Mark Beckman, and Beau Proffitt led the Pledge of Allegiance.

Public Session:

No one from the public was present.

Consent Agenda: The minutes for October 7, 2025, were approved.

Executive Session: At 7:05 PM Chris King made a motion to go into Executive Session to receive legal advice relating to a pending, threatened, or potential claims or other matters covered by the attorney-client privilege, as provided by SC Code Section 30-4-70(a)(2). This item concerns legal advice regarding municipal compliance with state enabling laws relating to land use matters. This session may also include Legal, Contractual, and/or Personnel Matters per SC State Code Section 30-4-70(a). Executive Session pursuant to S.C. Code Section 30-4-70(a)(2) which may include discussions related to proposed potential contractual arrangements, legal matters, and various personnel matters including Council appointments Council may or may not act upon the matters discussed in Executive Session upon returning to regular session. Beau Proffitt made the second and the vote to go into Executive Session was unanimous.

Regular Session: At 8:54 PM Chris King made a motion to go back into Regular Session, Beau Proffitt made the second and Mayor Atkinson asked if there were any post Executive Session motions.

Post Executive Session Motions: Beau Proffitt made a motion to employ SC Site Work, LLC at a base price of \$5,500.00 to perform site preparation for the Bryson Children's Nature Walk (BCNW) garden area. Chris King made the second and the vote carried unanimously.

Beau Proffitt made a motion to reaffirm Chris King as Mayor Pro-Tempore: Mark Beckman made the second and the motion carried unanimously.

Agenda Items:

Beau Proffit made a motion to approve the second reading to amend the Ordinance #1207202. Chris King made the second and the vote to adopt the updated Ordinance was unanimous.

Committee Reports

- Administration / Finance / Greenspace (Mayor Atkinson):
 - Noted a great turnout for the planting of trees at BCNW. Trees Upstate raised money to buy the trees and volunteers from across the upstate planted them.
 - Financials look great four months into the fiscal year.



 - No report


Adjournment
