

# Regular Council Meeting

Tuesday, June 3, 2025

The Regular Town Council meeting was held by the Six Mile Town Council at Town Hall (106 South Main Street, Six Mile, S.C.) on June 3, 2025, at 7:00 PM. Members in attendance were Mayor James Atkinson: Presiding; Council: Mark Beckman, Chris King, Beau Proffitt, and Judy Shaw. The agenda was emailed to the Pickens County Courier and the Journal on June 2, 2025.

## **Call to Order & Invocation**

Mayor Atkinson asked Chris King to give the invocation; he then asked Judy Shaw to lead the Pledge of Allegiance.

## **Public Hearing:**

Mayor Atkinson called the public hearing into session and gave a summary of the Rules of Decorum to be enforced. He then asked if there was anyone wishing to comment. Hearing none, he closed the public hearing and proceeded with the agenda.

Beau Proffitt made a motion to adopt a Proclamation recognizing the Six Mile 14U Flag Football Team for winning the 2025 Tri-County Flag Football Championship, Chris King made the second and the vote to adopt the proclamation was passed unanimously.

Mark Beckman made a motion to adopt a Proclamation recognizing the Six Mile 12U Flag Football Team for winning the 2025 Tri-County Flag Football Championship, Beau Proffitt made the second and the vote to adopt the proclamation was passed unanimously.

## **Public Session:**

Mayor Atkinson asked Clerk, Rita Martin, if anyone signed up to speak in public session and was told that no one had.

Next was discussion for a public meeting dedicated solely for input on Downtown Community Park and Community Park Annex. After some discussion it was decided that the meeting will be held June 26<sup>th</sup> from 6-7pm.

Chris King made a motion to go into Executive Session for the purpose of Legal, Contractual, and/or Personnel Matters per SC State Code Section 30-4-70(a). Executive Session pursuant to S.C. Code Section 30-4-70(a)(2) which may include discussions related to proposed potential contractual arrangements, and various personnel matters at 7:35 pm. Judy Shaw made the second. The vote to go into Executive Session was unanimous.

Mayor Atkinson called the meeting back to regular session at 8:40 PM and asked if there were any motions to come from Executive Session.

Beau Proffitt made a motion to accept the resignation of Mark Reeves from the Six Mile Recreation Board. Judy Shaw made the second and the vote to accept the resignation passed unanimously.

Beau Proffitt made a motion to appoint Glenn Hughes to the Six Mile Recreation Board effective immediately for a term of three years. Chris King made the second and the vote to appoint Glenn Hughes was unanimous.

Beau Proffitt made a motion to authorize Mayor Atkinson to enter into a contractual relationship with Twin Oaks Design for a schematic of the Downtown Community Park as well as the Bryson Boardwalk and Pond Overlook (the latter paid for with donation or grant funds). Mark Beckman made a second and the vote authorizing the Mayor on this matter was passed unanimously.

## Consent Agenda

The minutes for May 6 and 15, 2025, were approved.

Administration/Finance/Greenspace: Chairman Atkinson had nothing to report.

Public Health and Infrastructure: Chairman King had nothing to report.

Recreation: Chairman Proffitt had nothing to report.

HR/Volunteers: Chairperson Shaw had nothing to report.


Beau Proffitt made a motion to approve the second reading of the FY26 Budget in the amount of \$486,213 and the FY26 Non-Reverting Recreation Budget in the amount of \$90,600. Mark Beckman made the second and the vote to pass the second and final reading of the FY26 Budget was passed unanimously.

Chris King made a motion to adjourn; Beau Proffitt made the second and the meeting was adjourned at 8:50 PM.
